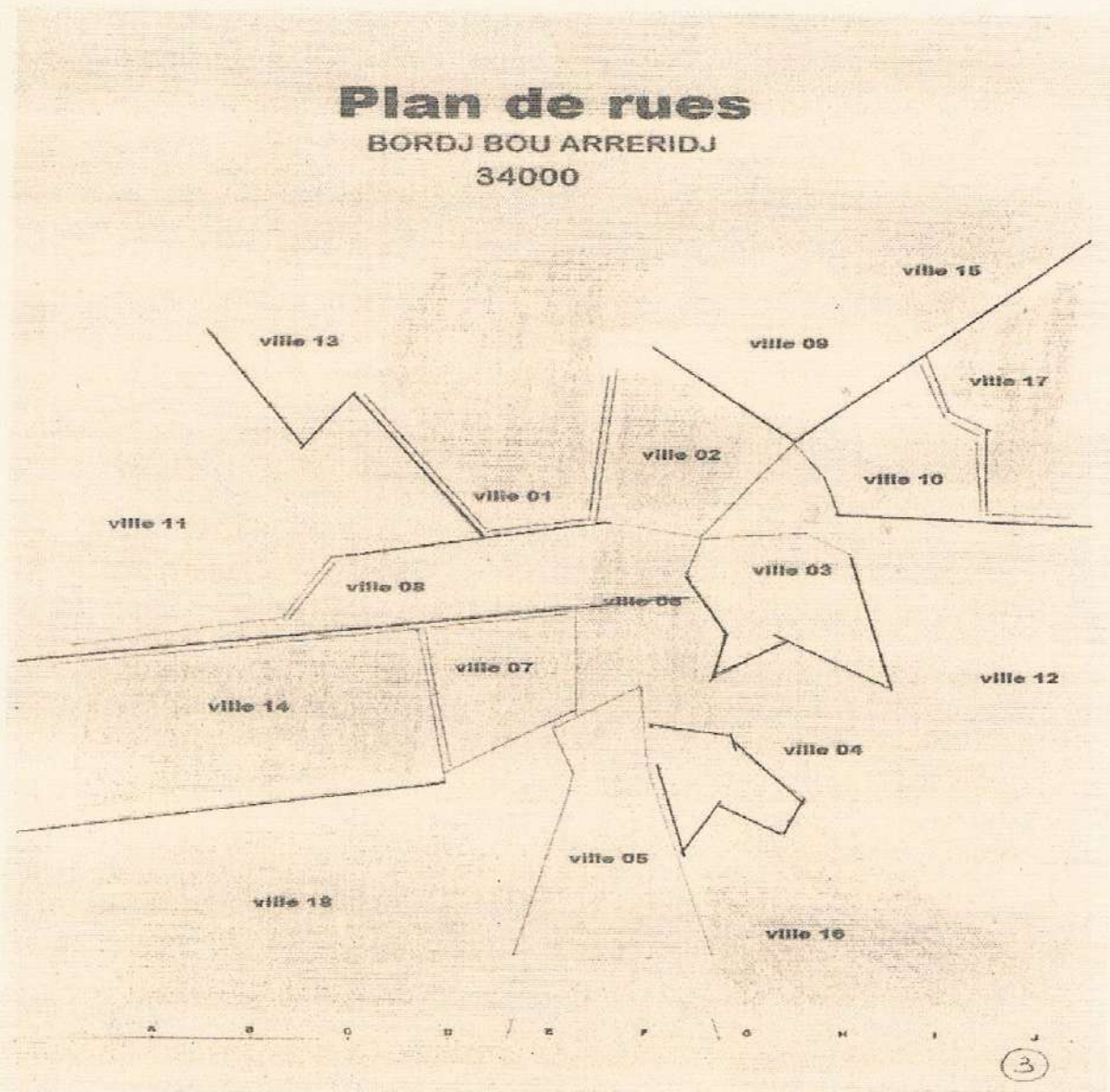
• Présentation

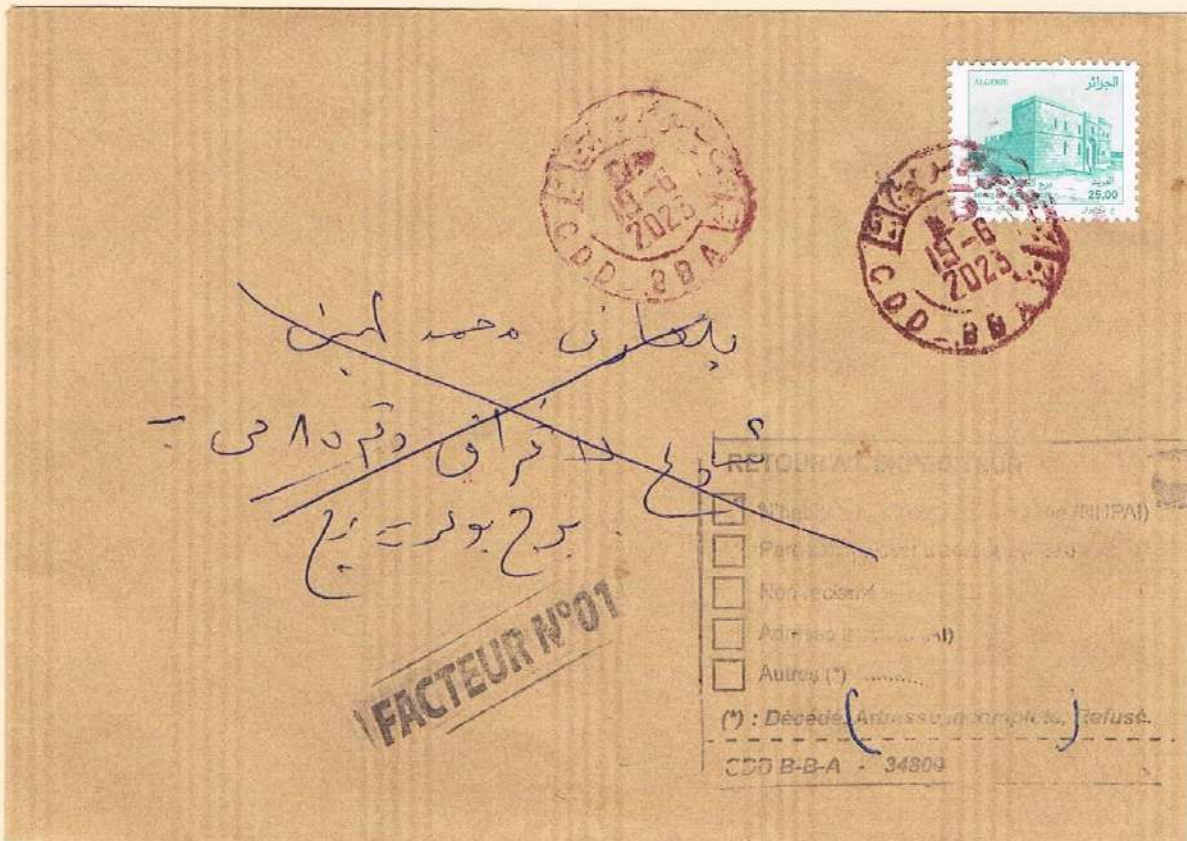

LE C.D.D (distribution centre)

The distribution centre consists of a grouping of factors from the neighbouring postal establishments. Its main mission is the distribution of mail within the boundaries of its geographical exchange with all related activities. Typically, the DDC exchanges a dispatch with the regional hub located in the same riding. The DDC is essentially responsible for:

- Home delivery of all categories of mail (regular, loaded, registered, CH28 etc.)
- Distribution to the box office and post office boxes for establishments that have post office boxes and counter space.
- Home delivery of parcels (major locations).
- Distribution or sale of financial products, or other value-added products.
- Mail delivery to CIDEX premises.
- Lifting of additional mailboxes (if not provided by CTR).
- Collection of mail from contracted customers (if not covered by CTR)

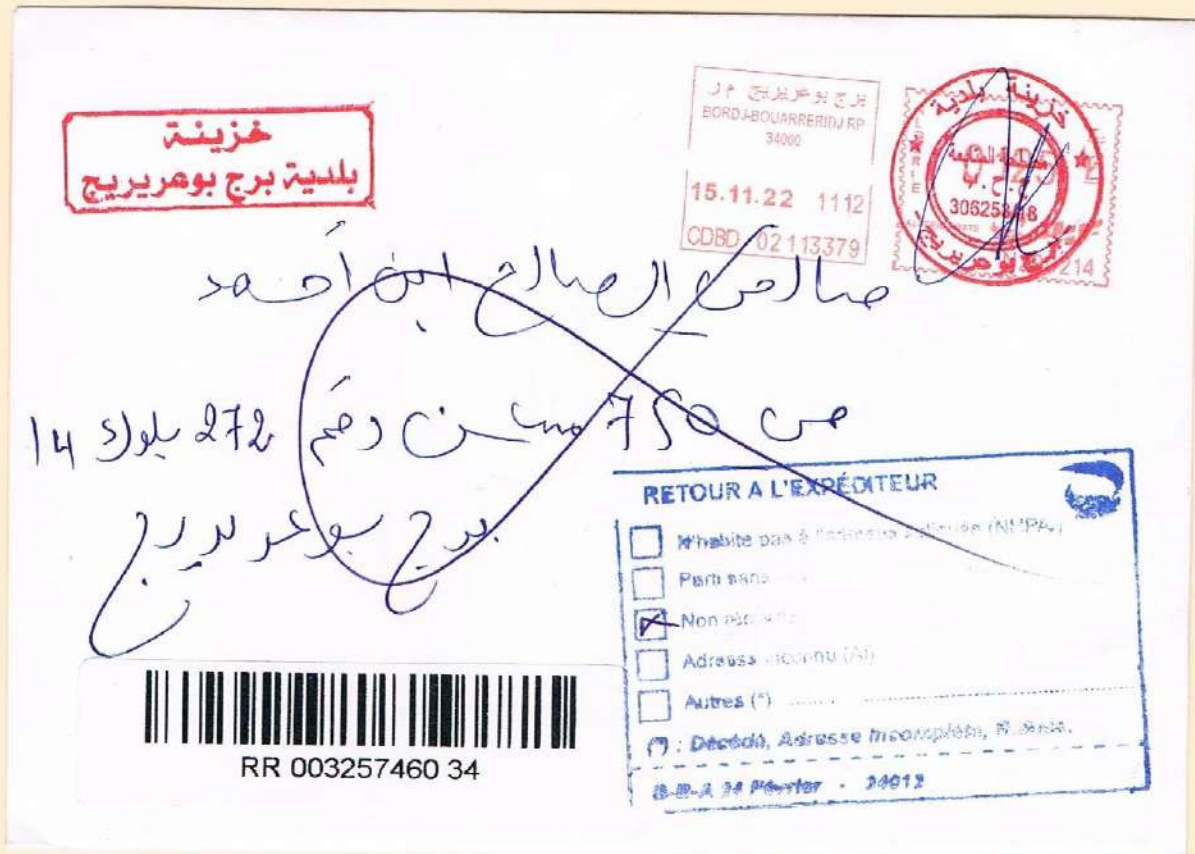

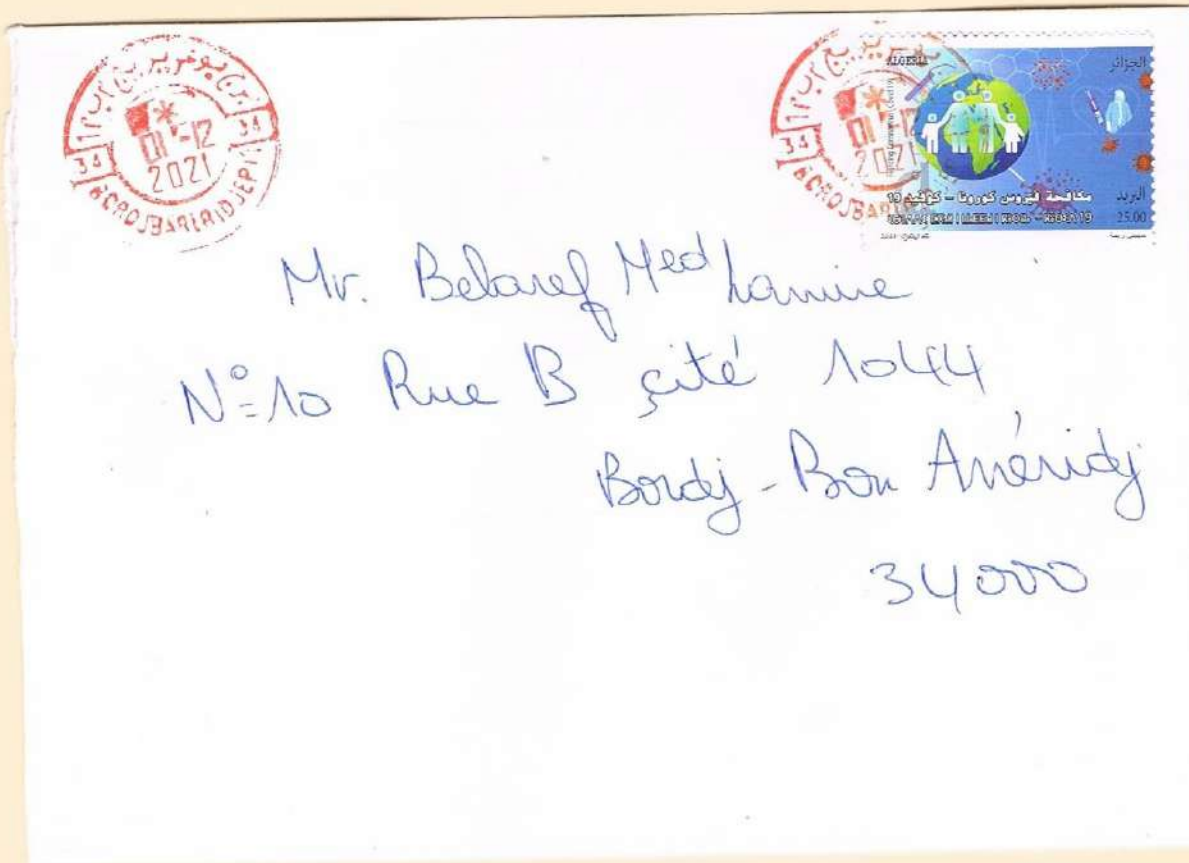

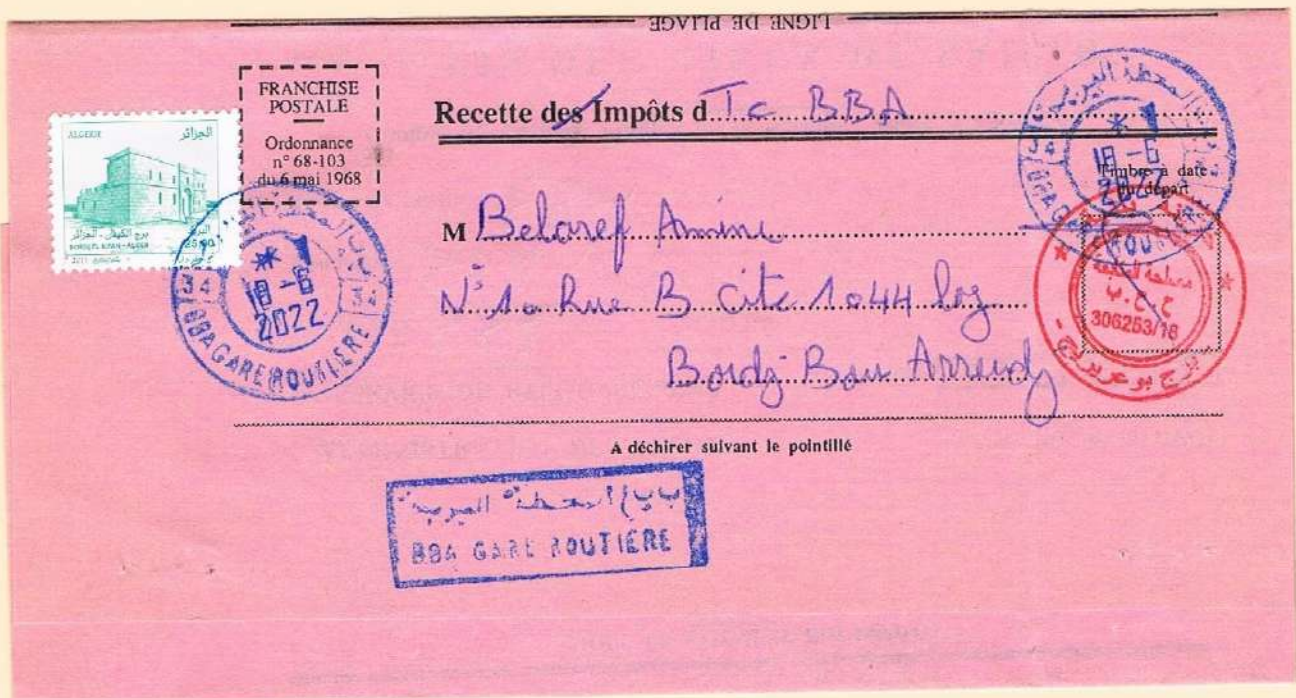

Postal establishment itinerary 1



















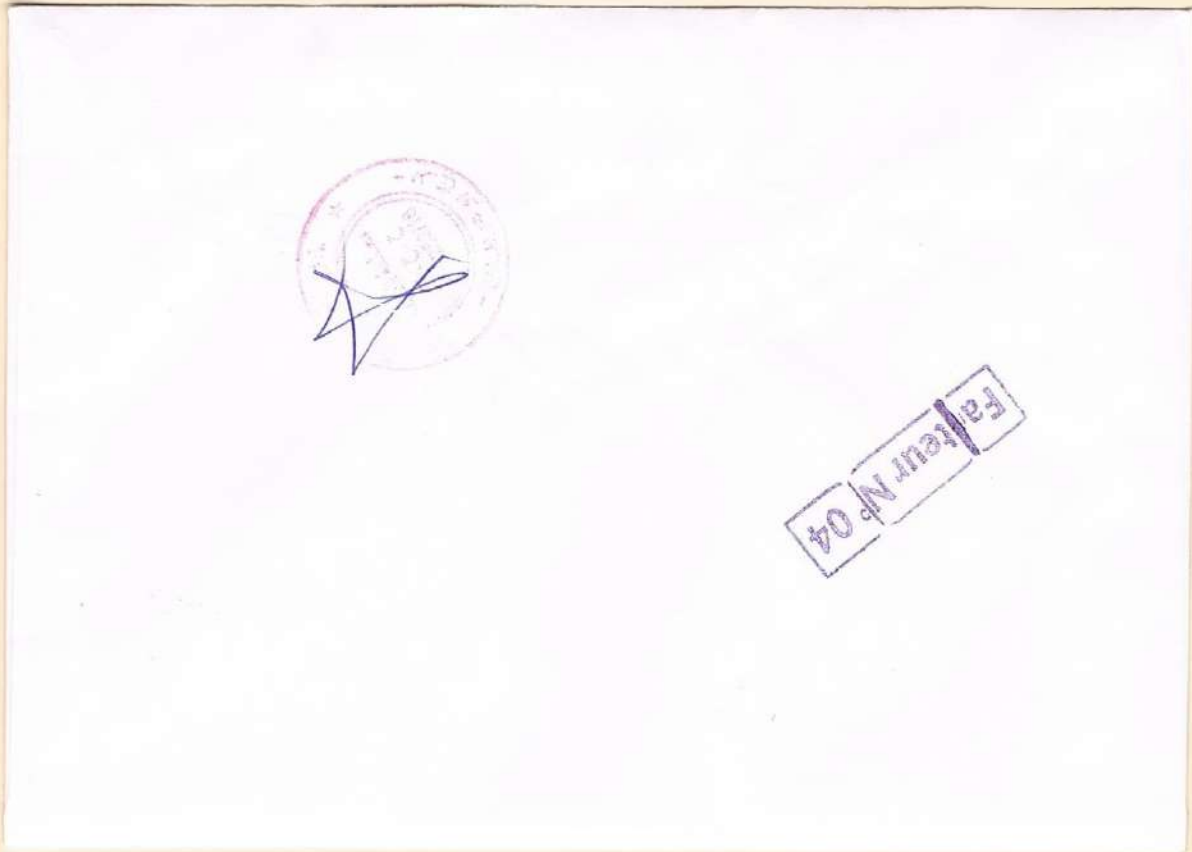

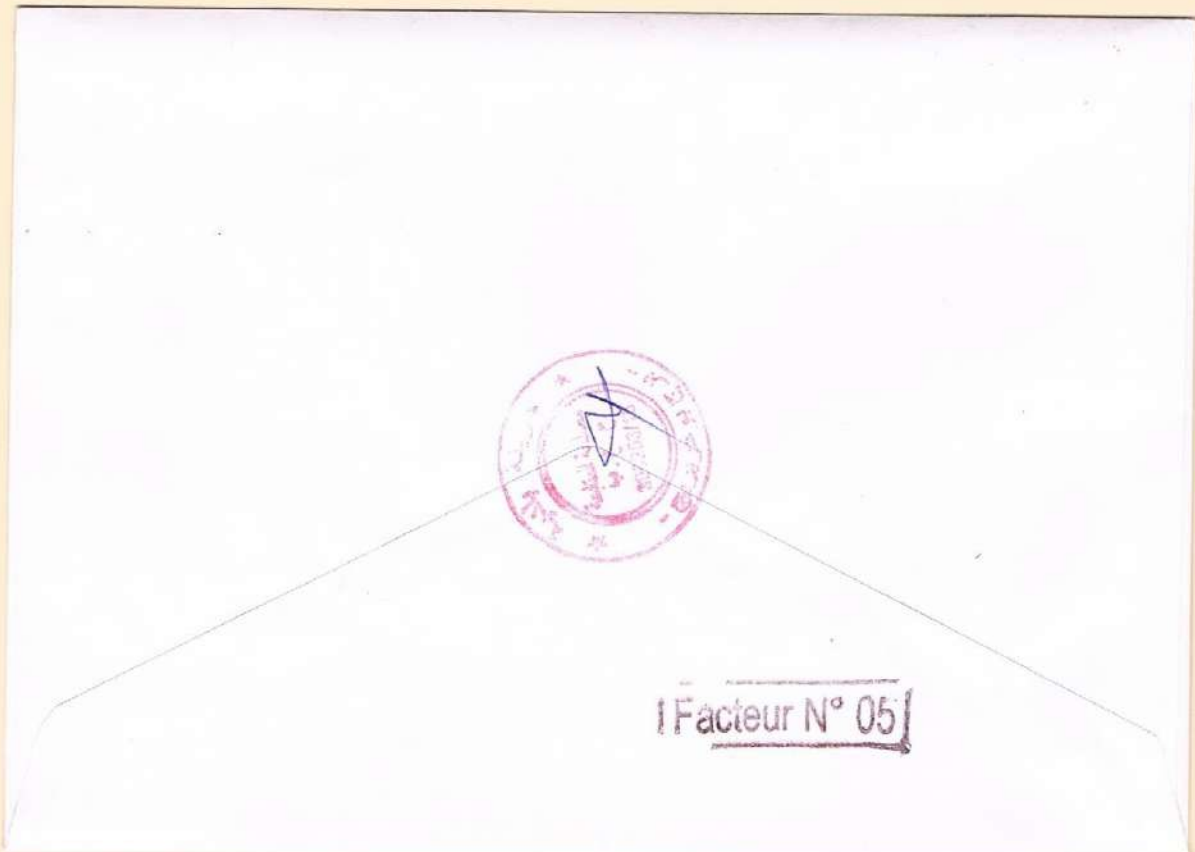


Registered letter of the 17/10/2022. 125da, fees of a letter up to 20g.

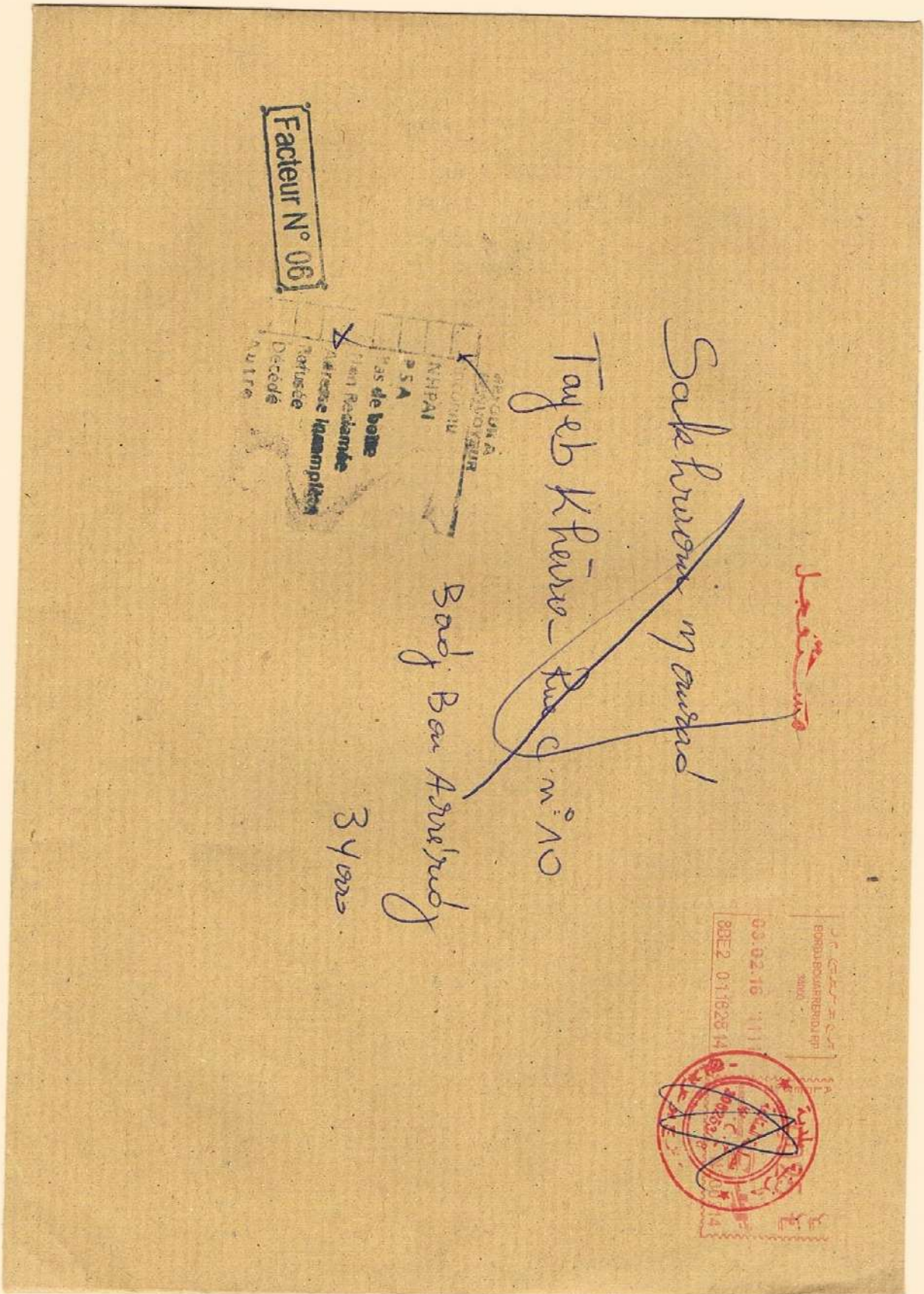


Normal letter of 03/04/2022. 25da, fees of a letter up to 20g.
